5. Mayor's communication

5.1 ACTING MAYOR'S REPORT

It has been an interesting busy time with key pieces of work which will help set the council's future in areas such as climate change, planning and water management.

CEO Recruitment

Council received feedback from the community and staff regarding the appointment of Alastair Dawson to the role of Chief Executive Officer.

Considering the feedback, and with the best interests of the community and council's employees in mind, Alastair Dawson and the City of Onkaparinga have mutually agreed not to proceed with the intended appointment of Mr Dawson as CEO.

Expenses incurred by council with Mr Dawson are limited to reimbursement for preliminary relocation costs only. These costs are less than \$10,000.

The CEO recruitment process will be paused until after the November local government elections. Until that time Julia Grant will continue to serve as acting CEO.

Climate Change Response Plan

City of Onkaparinga wants your feedback on its draft Climate Change Response Plan 2022–27.

The plan sets out 79 actions, 5 pillars outlining key action areas, providing clear strategic direction to inform council's role in helping the city mitigate and adapt to a changing climate.

I urge everyone to review our draft plan at our Your Say page before Thursday 14 July and provide your feedback on the actions, projects, practices and initiatives we want to undertake over the next five years.

Community feedback on the draft will inform updates to the plan, which will be presented to Council for endorsement in August 2022.

Towards Zero Emissions Roadmap

The City of Onkaparinga has developed a Towards Zero Corporate Emissions Roadmap, which sets a target of 80 per cent reduction in its corporate greenhouse gas emissions by 2030.

The roadmap builds on council's slashing of emissions by almost half over the past decade following a slew of energy-reducing projects.

Its 2030 timeframe has been identified by the Intergovernmental Panel on Climate Change as the most critical to making rapid, deep and sustained greenhouse gas emissions cuts to limit global warming.

The roadmap outlines how council will achieve its target across four key areas:

- buildings continue to install solar and improve energy efficiency in council-managed buildings
- streetlighting to be 100 per cent LED by 2025
- fleet and plant– ensure 80 per cent of council fleet vehicles are electric or hydrogen by 2035
- recycled material buy back 50 per cent of kerbside recycling plastics collected by 2024-25.

I'm proud of council's track record in managing corporate emissions in a financially sustainable manner.

We've been tracking and reporting on our corporate greenhouse gas emissions since 1998, and we've managed a 47 per cent reduction in corporate emissions since 2020-11. Our energy use has also reduced by 33 per cent during the same period.

Our new roadmap builds on this by setting a trajectory toward an ambitious but achievable further reduction in our emissions.

Reductions to date included changing 12,000 streetlights to 14-watt LED technology in 2018, installing 1000 solar panels at council's three highest energy-consuming sites, and circular procurement targets prioritising recycled materials in council projects.

The roadmap's projects are primarily funded through council's Revolving Resources Fund—dedicated to funding energy efficiency, renewable energy and sustainability projects that generate cost savings. These savings are put back into the fund for reinvestment in future energy-reducing projects.

The roadmap projects will not only be good for the planet, they'll continue reducing our operating budget by lowering ongoing costs of fuel and electricity, which is great news for our ratepayers.

Water assets – possible divestment

In another important engagement, you can have your say on the future of water assets managed by council.

We have a Community Wastewater Management Scheme that operates in several areas which don't have access to the SA Water network.

We also have a Water Business Unit that provides water for irrigation of public spaces.

Council will soon decide on whether to divest these assets, and we want to hear from you.

There are surveys available online, or in person at our offices and libraries, and we are holding information sessions across the region starting on June 27.

McLaren Vale Township Policy Review

Following community feedback, Council will soon negotiate with the State Government about a range of changes to development policy in the McLaren Vale Township area.

The overall aim has been to ensure appropriate management of development while enhancing and protecting significant character elements within the township.

The changes include

- limiting residential development by changing allotment sizes
- creating new zones to better reflect the role and character of the main street and encourage appropriate future development opportunities

 - 1b Resolves that the car park and the former community building will be demolished at an approximate cost of \$25,000. Financial allocation for this activity will be included in the future PCW bids for scoring and prioritisation in accordance with Council's budget process.
 - 1c Resolves that a request be forwarded to the Minister for Local Government seeking approval to revoke the subject land from its community land classification to enable disposal.
 - 1d Resolves that a final update report be presented to Council once the Minister's decision regarding the proposed revocation has been received, to enable finalisation of the revocation and disposal process.

9.4 BY-LAW 7-DOGS REVIEW

- 2. In exercise of the powers contained in section 246 of the Local Government Act 1999 (the Act), having satisfied the consultation requirements of the Act and having had regard to the outcome of the consultation process, the National Competition Policy Report, the Certificate of Validity provided by the Council's legal practitioner and the comments from the Dog and Cat Management Board, the majority of Council, in the presence of at least two thirds of its members, hereby makes the following by-law as attached and marked Attachment 1, Dogs By-law No. 7 of 2022.
- That the Chief Executive Officer be authorised to undertake all steps necessary to finalise the by-law review process and to give effect to the newly adopted by-law.

- 1. That for the council owned land described as Allotment (Reserve) 27 in Deposited Plan 34194 comprised in Certificate of Title Volume 6220 Folio 710 and bordered in red on Attachment 1 to the agenda report, Council:
- 2. Declares that the subject Council owned land is surplus to community land requirements and suitable for disposal to the Applicant (adjoining landowner) of the land bordered in yellow in Attachment 1 to the agenda report subject to:
 - a. the prior completion of a successful revocation of community land process; and
 - b. the registration of a 3-metre-wide drainage easement in favour of Council to protect existing public stormwater infrastructure.
- 3. Approves the commencement of the revocation process to revoke the community land classification, including undertaking public consultation in accordance with the provisions of subsection 194(2) of the Local Government Act 1999 and in accordance with the Community Engagement Plan included as Attachment 2 to the agenda report.

- 4. Approves that if the subject land is sold to the Applicant it will be sold at no less than the market value to be determined by an independent licenced land valuer, and all costs associated with the transaction will be borne by the Applicant not Council.
- 5. Approves the net proceeds from the sale of the subject land as a contribution towards the annual \$3 million-dollar budgeted revenue to be raised from the sale of surplus assets in accordance with the endorsed Long-Term Financial Plan and the 2021-22 budget to fund prioritised projects.
- 6. Requests a further report be presented to Council detailing the outcomes of the public consultation phase of the revocation process to enable Council to determine if the revocation should proceed.

- 7. Do not approve accepting funding to deliver a new toilet facility at the Original Open Market site in Christies Beach due to the site being used infrequently, ongoing cost to maintain and future asset renewal requirements.
- 8. Approve accepting funding for a new dog park in Hurtle John Potter reserve, Woodcroft Seconded by Cr Greaves.

I can say it has been an interesting 25 years and the City of Onkaparinga has changed completely in my time as a Mid Coast Councillor

Recently residents, friends and visitors have been asking me questions about the early years and my standard answer now is "It was like the wild west. A time I enjoyed!

What's changed

We were extremely lucky initially that we had a great CEO Geoff Tate who gathered around him very talented Directors and staff and together we started to build the Councill that created this great city.

One idea I had was for what I called the golden triangle

I can remember meeting with Geoff and his Officers at separate times for a trip to the Golden Triangle. The triangle went from the base of Christies beach to Port Noarlunga with Colonnades the apex.

My view was that area was the centre of our commercial development

The end was that both Beach Road and Port Noarlunga were upgraded

SLSCs

All Five City of Onkaparinga SLSCs were upgraded in the as we led a state-wide refurbishment and renewal plan for all the SLSCs in S.A.

We also joined all the other Metro Coastal Councils in building the Coastal trail from Sellicks Beach to Outer Harbour. We still however have some work to do on this project.

And now Route 31 the Coastal Drive

is a feature of our 31km of coast. This drive has been on our books as long as the Witton Bluff Trail. I can hardly wait for people to explore our magnificent coast which also just happens to be a Surfing Reserve and occasional hosts Whales to allow them to recover for the rest of the trip south.

The City of Onkaparinga has facilities for all sports and now is upgrading these facilities. Port Noarlunga Sports and Social Club is undergoing a rebuild to replace the 60-year-old Club Rooms. Christies Beach is also the same age and is seeking a refurbishment

One outstanding new completed development is on Morton Road Christie Downs. The Morton Road Reserve houses a community Centre, New Tennis facilities and a very modern Skate Park that can hold National Skating events.

Hopgood Theatre

Council is working with the State Government to clarify how the Hopgood is to be managed. The Hopgood Theatre is an essential part of Ramsay Place and a fantastic home for the Arts on the Fleurieu Peninsula

I feel I have been lucky to be part of teams that has taken us from the wild west to a very modern society. I am also looking forward to be working with community members

However, we still have some issues with maintaining appropriate open space in our communities when we seem to have State Governments hell bent on reducing the size of housing blocks
