# INTRODUCTION

The draft Knox Park Multi-use Sport Park Concept Plan has been prepared to guide the development of sport and recreation facilities at Knox Park.

The Southern Athletics Club (SAC) approached City of Onkaparinga in 2017 seeking a permanent home for athletics in the southern metropolitan region and Knox Park in Morphett Vale was identified as a potential location.

Following the completion of a Knox Park Feasibility Study and community engagement for an amendment to the Community Land Management Plan (CLMP), Council resolved at a meeting on 11 September 2018 to commence development of a site masterplan (hereon referred to as a concept plan) to progress a multi-use (including athletics) sporting facility at Knox Park.

Council also approved an amendment to the CLMP which reclassified Knox Park from a 'reserve' to a 'district level sportsground'.

Since 2018, council has undertaken several investigations to inform the design and has been working closely with the SAC to develop a draft Concept Plan to guide the staged development of Knox Park into a multi-use sports park.

The draft Knox Park Multi-use Concept Plan has been designed to provide a home ground for athletics as well as providing flexible turf playing space that can accommodate soccer, AFL football and other turf sports.

The draft Concept Plan is broken into short, medium and long-term priorities. The plan is future-proofed and identifies long-term actions which can be accommodated subject to changes in demand and funding.

Delivery of the complete concept plan (short, medium and long-term priorities) will:

- Provide a home ground for SAC
- Maximise flexibility and opportunities for athletics and other turf-based sports
- Deliver an attractive sports and passive recreation park
- Enhance the passive recreation opportunities for adjacent communities including an upgraded playground and perimeter walking trail
- Improve pedestrian linkages
- Assess traffic management requirements including access and car parking for future use
- Enhance the tree canopy and environmental sustainability.

### COMMUNITY ENGAGEMENT

Previous community engagement was undertaken in May 2018 to determine the support for a proposed change in CLMP classification of Knox Park from 'reserve' to 'sportsground'. A total of 201 submissions were received with 92% (184) of respondents in support of the amendment.

Preliminary engagement has been undertaken with the SAC to identify current and future requirements for an athletics home ground. This information has informed the draft concept plan.

The purpose of the community engagement was:

- To engage with key stakeholders (Clubs) seeking input into the design of the sports field and supporting sports infrastructure (for athletics and other turf-based sports)
- To understand from key stakeholders their sports facility needs
- Consult the local community, gauge support for the concept plan, identify any issues and seek local knowledge which may impact on the design.
- Inform the community of all aspects of the concept, the short, medium and long-term actions.

The objectives of the community engagement were:

- To engage with key stakeholders most impacted to seek input into the design
- Provide opportunities for the community to have their say on the concept design, gauge the level of support for the project, and seek local knowledge which may inform the plan.
- Identify any issues that need to be addressed
- To keep all stakeholders informed of progress of the project and how their feedback may have influenced/contributed to the plan.
- Through evaluation, more than 75% of engaged participants find it easy to engage with us. (This evaluation will occur when rounding back to the community with the outcomes/decisions made. An evaluation report will be made available)

# **ENGAGEMENT TECHNIQUES**

During the engagement period a Knox Park local residents group formed via Facebook in response to concerns with aspects of the draft concept plan. A spokesperson from this group presented a deputation to Council on 21 June 2022 outlining a number of concerns with the draft concept plan. A Notice of Motion (NOM) was presented by Councillor de Graaf to the adjourned 21 June 2022 Council meeting held on 23 June 2022.

In response to the deputation and Notice of Motion, the engagement period was extended from 25 May to 22 June 2022 to 25 May to 30 June 2022.

Engagement techniques used included:

- Your Say Onkaparinga website page consisting of background information, 'Frequently Asked Questions', draft Concept Plan, and feedback tools.
- Emails (a total of 1,963) sent to stakeholders listed on the Community Group Register and registered members including 256 sports related.
- Roadside banners were erected along Main South Road adjacent Knox Park and two on-site signs were erected in the reserve.
- City of Onkaparinga corporate website provided a link through to the Your Say page.
- Letters were sent to members of council's First Nations Peoples Advisory Group seeking comment on the draft concept plan.
- Elected Member update.
- Letters were delivered on 25 May 2022 to approximately 370 properties surrounding Knox Park

- Facebook Post on the City of Onkaparinga's corporate Facebook site.
- An on-site drop-in session was held on Saturday 18 June 2022 between 2pm and 4pm and included the collection of feedback from adults and children.
- Meetings were held with key stakeholders:
  - meeting on 30 June 2022 with two representatives of the Local Residents Group, SAC, Athletics SA, Mayor McMahon, Cr De Graaf and council staff.
  - A follow-up meeting was held on 14 July 2022 with just the resident group representatives and staff.
  - Noarlunga Districts Junior Soccer Association on 13 July 2022.

# **EVALUATION**

A summary of the Knox Park multi-use sports park engagement on the Your Say webpage is as follows:

- 719 people visited the Your Say Onkaparinga project page
- 313 people downloaded a document (ie. concept plan)
- 427 people were **informed** about the project; and
- 111 people were engaged about the project.

Of those engaged, 96 were City of Onkaparinga residents, including 37 from Morphett Vale. The remaining 14 were located outside of our city and one entry was not valid and no information recorded.

The majority of traffic was generated from social media with the email and newsletter the secondary traffic source.

In addition to the above, approximately 30 to 40 people attended the on-site engagement drop-in session.

A formal evaluation of the engagement process will take place when a decision has been made and the community notified of the outcomes of the project.

# **SUMMARY OF COMMUNITY ENGAGEMENT OUTCOMES**

The community engagement outcomes show that the majority of respondents are in support of the draft Knox Park Multi-use Sports Park concept plan.


# **Online Survey**

During the engagement period, 111 people provided feedback via the online survey.

The survey asked respondents to tell us how much they supported the draft Knox Park Multi-use Sports Ground.

A summary of these responses is as follows:

- 84.7% (94) responses were **supportive** of the proposal
- 2.7% (3) responses were **impartial** or unclear
- 12.6% (14) responses were **not in favour** of the proposal. The majority of those not in favour are local residents living close to Knox Park.



To what extent do you support the concept plan?

Survey respondents were provided an opportunity to **comment** and those not in support of the draft concept plan were asked to **provide reasons for not supporting the plan**.

Verbatim comments are included in appendix A and these are summarised by themes in the following table.

# On-site engagement drop-in session.

Approximately 30 to 40 residents and users of the sports park attended the on-site information session held on 20 June 2022.

Written comments can be found in appendix B and these have been summarised by theme in the table below.

#### Meeting with representatives from a local residents' group

During the engagement period a Knox Park local residents group formed via Facebook in response to concerns with aspects of the draft concept plan. There are 34 Facebook members. A spokesperson from this group presented a deputation to Council on 21 June 2022 outlining their concerns. The group also distributed a flyer (appendix D) to local residents.

In response to this deputation and a Notice of Motion presented to the Council meeting on 23 June 2022, a meeting was held on 30 June 2022 with two spokespeople from this group. Council staff, Mayor McMahon and Councillor De Graaf attended the meeting. A follow up meeting was held on 14 July 2022 with staff and the two spokespeople.

The spokespeople emphasised that the residents' group are supportive of the sports park upgrade but have concerns with aspects of the design. The main concerns include the location of the proposed buildings (toilet and shed), vehicle access and car parking on the residential side of Knox Park. Residents are concerned with increased traffic and car parking along the local streets, security and visual impact of buildings to adjacent residents.

In order to address these concerns, the group requested that all buildings and car parking be located on the Main South road side of Knox Park away from the residential side of Knox Park. This would require a direct access off Main South road into either Coorumbena Crescent or Kantalpa Grove and into a new car park.

Responses to the issues raised by the group are summarised in Table 3 below.

# **Noarlunga Districts Junior Soccer Association**

A meeting with this Association was held on 13 July 2022. The Association is interested in using Knox Park as a home ground and for Saturday matches in terms 3 and 4. This Association runs a school-based competition and operate indirectly through Football South Australia. A total of 20 schools participate in this competition and teams range in age from Under 6s to Under 13s.

The teams operate out of school ovals (training and matches).

The Association is interested in using Knox Park as a venue for their representative teams to meet for semi-finals and finals. This would involve Saturday afternoons in June (state championships) and August (country championships).

Council will work the Association and consider Knox Park as an option in the future once we are clearer about future users.

# SUMMARY OF COMMENTS AND PROPOSED RESPONSES OR RECOMMENDATIONS

A summary of main comments received on the draft concept plan is included in Table 3 below along with our responses and/or recommendations.

# Main South Road access in short-term priorities

A direct access off Main South Road will divert traffic away from residential streets and address concerns with increased traffic and car parking on the residential side of Knox Park

- 7 survey respondents
- 2 comments from the drop-in session
- Local residents' group

access and car park (40 car park spaces).

It is envisaged that the current car park will provide sufficient car park spaces to meet expected demand in early years following the development. There will be times where the local streets will be used for parking and there would be a range of measures available to manage this if required including introducing traffic controls such as line marking, no parking signs and off-road overflow car parking.

The traffic and car parking will be monitored over time and if use increases and funding is secured, this could trigger the need for a car park extension or new access off Main South Road, which are both identified as long-term priorities in the concept plan.

To bring forward these priorities and accommodate them in stage 1 would require a substantial additional budget.

Recommended amendment to the concept plan:

It is recommended that the following two options for a car park extension are provided in the long-term priorities:

- extension to the current car park on the western side of the reserve and
- a new car park on the eastern (Main South Road) side of the reserve.

The revised long-term concept will include three options for a new vehicle access point off Main South Road (into Kantalpa Grove, into Coorumbena Crescent and directly into the reserve) and be subject to demand, significant funding and Department of Infrastructure and Transport (DIT) approval.

# Buildings and car parking to locate on Main South Road side of Knox Park away from residents

Concerns with the location of the proposed on the residential side of the park (visual impact and security)

- 4 survey respondents
- 4 comments in the drop-in session
- Local residents' group

The toilet facility should be secure with adequate lighting and be

The toilets will have adequate lighting and will be locked at night.

In response to concerns raised in the engagement, the following two options were discussed with the local residents' group spokespeople:

• **Option 1:** Retain the buildings (toilet and shed) on the western side of Knox Park but move the buildings further east and down the existing sloped embankment.

Advantage: this option reduces the visual impact from residences and retains the toilet in close proximity to the playground and existing carpark.

Disadvantage: One of the spokespeople was concerned with security issues and the potential for anti-social behaviour to congregate around these buildings.

• 6 comments in the drop-in session

• **Option 2**: Move the buildings to the Main South Road side of the park

Advantages: the buildings and security concerns would be away from the residential side of the park

Disadvantages: The playground and car park (and vehicle access) are currently located on the western side of the reserve. There is no existing vehicle access or car parking on the eastern side of the reserve. If the toilet and sheds are moved to the east, this will trigger the need for the following (at significant additional cost):

- o requirement for disability access and DDA compliant car parking to access the toilet
- o vehicle access to the sheds and toilet
- o due to the large distance from the playground (180m around the oval), this would require the playground to be moved closer to the toilet (ie to the eastern side)
- o a new car park located next to the playground with a new entrance and exit from either Main South Road and/or from Kantalpa Grove or Coorumbena Crescent.

The spokespeople's preference is for option 2 above but it was suggested that option 1 may be acceptable as a compromise subject to the buildings being located along the eastern edge of the current car park rather than opposite the Nerida intersection.

The spokespeople wanted to go back to the local residents' group before providing Council with further feedback on this. We were subsequently advised that the local residents' group would not provide further feedback on this issue and would seek a review of the community engagement process.

In response to the security concerns raised above, council's security team conducted a Crime Prevention Through Environmental Design (CPTED) audit of the site and reviewed the building location options. From a CPTED perspective the original location identified in the draft concept plan is the preferred location as it has good natural surveillance from Kalimna Walk, Nerida Lane and Kantalpa Grove.

An alternative location (option 1 above) further down the hill and to the east of the car park was also acceptable with natural surveillance from the surrounding streets.

The proposed upgrade of the playground (and sports fields) in close proximity to the buildings in either location on the western side of Knox Park would increase use and therefore public surveillance of the site.

Option 2 with the toilet located along Main South Road, while

having good surveillance, would provide an easy access and exit and provide more opportunity for vandalism (and potentially exacerbate security concerns).

Recommended amendment to the concept plan - location of buildings:

It is recommended that Option 1 is supported and the

It is recommended that Option 1 is supported and the buildings are moved to the east of the current car park and down the sloped embankment.

# **Vegetation and wildlife**

Need to retain/enhance native trees and plantings; and concern that the proposed development will disturb local wildlife (koalas and native sweat bees)

- 7 survey respondents
- Local residents' group

A substantial budget of \$200,000 has been earmarked in stage 1 of the project for priority landscaping and tree planting. The proposed development of Knox Park into a multi-use sports park will enhance and not reduce the number of trees or understorey vegetation on the northern, western or southern edges of Knox Park.

The existing eucalyptus trees (western Australian 'swamp yate') along the eastern boundary of Knox Park and western verge of Main South Road were planted approximately 30 years ago. These are in poor condition and the species is unsuited to the local conditions. During a storm event last year many (approximately 30) trees fell over. The remaining swamp yate trees are in poor health however and most will require removal and replacement as part of Council's standard tree management processes due to safety concerns.

We have been successful in receiving \$20,000 from the Planting Trees for the Queen's Jubilee grants program for a row of approximately 50 large (at maturity) feature trees at the boundary of Knox Park and South Road. These will provide shade for walkers and an attractive and defining environmental edge to the proposed Knox Park upgrade.

A separate community engagement process will be undertaken for the Queen's Jubilee tree planting program.

# **Increased noise**

The sports park will create noise in a quiet neighbourhood

- 5 survey respondents
- Local residents' group

Some increased noise is an inevitable outcome of a sports park but this can be managed to some extent by limiting the times of operation through future leasing arrangements.

# **Artificial turf**

Concern with artificial turf heating up in summer and releasing fumes

- 3 survey respondents
- Local residents' group

Synthetic turf is identified in the northern 'D' shaped section of the oval in the long-term priorities (plan 2, attachment 2). In the longer term a durable surface will be required in this high use area for throw and jump modalities (discus, javelin, shotput and high jump). In the future if Stage 2 was to be funded the use of a synthetic pitch area would need to be reviewed against council guidelines, best practice and community concerns.

Recommended amendment to the concept plan:

Reference to synthetic turf be removed from the long-term priorities plan and be amended to: 'durable surface subject to best practice guidelines'.

#### **Additional facilities**

Suggestions for additional facilities included:

- shelters/gazebos (drop-in 5 responses)
- barbeque (survey 1 response, drop-in 4 responses)
- drinking fountain and dog bowl (drop-in – 4 responses, survey – 2 responses)
- dog park (survey 2 responses, drop-in – 3 responses)
- basketball (survey 4 responses)
- seating with tables (drop-in 2 responses)
- gymnastics, parkour, exercise equipment, pumptrack and bike track around perimeter, skate park, small club room, space for kite flying (each 1 response)

The current budget, council policy and future priorities will guide the facilities provided at Knox Park. The draft concept plan includes a couple of new shelters with seating (and tables) and a BBQ facility, drinking fountain and dog bowl will be delivered at the site.

There is limited space for a reasonably sized dog park in Knox Park. Council's Open Space Strategic Management Plan 2018-2023 defines council's current service level which is to provide three dog exercise parks across the city. These are located at Minkarra Park, Flagstaff Hill, Dinton Farm Reserve, Melsetter Rd Huntfield Heights and Symonds Reserve Aldinga. In response to a State Government grant, Council recently approved development of a fourth dog park in Woodcroft. This is 6km away in close proximity to Knox Park.

Knox Park will continue to be available for the off-leash exercise of dogs outside scheduled sports activities and the proposed fencing in the medium-term priorities will address the safety of walkers and dogs.

# **Playground suggestions**

A number of suggestions were made regarding the playground

- 5 survey respondents
- 5 children drew their 'perfect' playground ideas at the dropin session

The playground will commence in 2022-23 and will be part of a separate engagement process. Ideas from the drop-in session and survey will feed into this process.

Ideas included flying foxes, monkey/parallel bars, trampoline, slides, swings, ninja warrior junior, climbing wall/rope climbing nets, water/nature play and pump track.

# **Engagement**

The local community haven't been properly consulted in the development of the draft plan and their concerns raised in 2018 were not addressed

- 4 survey respondents
- Local residents' group

Engagement undertaken in 2018 (to reclassify the reserve to a sportsground) received 201 submissions. Six of these objected to the reclassification, 11 were in support but raised concerns and 184 were in support of the proposal. The main concerns covered many of the comments raised in this table and included: car parking, noise, dogs (access to the park), fencing, buildings and public access). Council were provided this information at the 11 September 2018 Council Meeting and decided to approve reclassification of the reserve and the commencement of a site masterplan (concept plan) to progress a multi-use sporting facility at Knox Park.

Engagement on the draft concept plan has followed the draft

	community engagement plan presented to Council on 17 May 2022.  Engagement on a draft concept plan provides an opportunity for the local community to provide comments on a tangible plan and for council to respond to their concerns.
Fencing  Do not want fencing around the oval; do want fencing along Main South Road  4 survey respondents	Fencing around the oval has been included in the medium-term priorities in the concept plan for safety reasons. This will prevent vehicles from driving onto the oval and will also stop children and visitors from crossing the oval when sports (including throws) are in progress. Fencing around the oval can be designed so that sections are kept open when sports are not using the oval, allowing passive recreation users to cross the oval easily.  Fencing along Main South Road has also been included in medium-term priorities.
Property values  Concern that increased traffic and the location of the toilet block will decrease the value of properties along Nerida Lane and Kantalpa Grove  Iocal residents' group	Locating next to a sports park is a matter of individual preference and opinions will vary on this matter. For example, a number of people living adjacent the park who attended the drop-in session said they were strongly supportive of the draft concept plan and a sports park.

Overall the community engagement process was successful in achieving the objectives of informing the community and stakeholders of the project and seeking feedback on the draft concept plan. In response to these comments, a number of amendments to the concept plan have been recommended (as outlined in Table 3 above).



Finance. \$1.1 million council contribution. I support the concept but not at this time. Financially it is a very difficulty time for many people. Food, fuel, power and council rates cost increases. The council should also show some financial constraint. There is already too much waste in our community.

As a local resident living and owning on the edge of Knox Park, I don't feel that adequate engagement and consultation have been made with those living in the vicinity of the park. I STRONGLY OPPOSE any form of fake turf or rubberized surfaces being used at any stage of the project. These surfaces when they get hot (even on a mid 20 degree day) can be over 80 degrees to touch and release a smell of burning car tyres. The chemicals and glues used to install them also release toxic chemicals. Neither of these is safe for people to use after installation or be around when it is done. There is no way to stop dogs from using the turf as a lavatory facility which causes bigger issues to maintain it. I am also allergic to the smell of many of these chemicals so using them puts me at risk in my own home. In addition, there is no need for it in this location as you are suggesting putting it in an unused portion of the design. The edge between any soccer/football fields would then become a transition tripping hazard and result in more injury than supporting anything. I STRONGLY oppose any fake turf. These streets are narrow with limited space when one vehicle is parked on the side of the road, not to mention having two vehicles parked on the side of the street. Having any form of opening of the streets at either end of the park to South Road will increase traffic, making the streets more dangerous for our children. My suggestion would be to have a carpark and toilet/storage facilities on the South road border of the park that does not connect to the residential streets. Surely having access straight into a carpark off South Road provides easier access as many are travelling from out of the area to join. I question whether any investigations have been done into having a small toilet block (that is only open during sporting

events) and small storage shed done on the South Road side of the space. I understand a need to have them for these sports and don't want to discount them completely but I don't feel the positions currently indicated on the plan are in the best interests of the sporting clubs or the residents. As a resident, I have some reservations about the drug use and crime that might come with a facility like this, particularly if it is open all the time. Knowing the challenges going on with conduct at Wirrenda High School and that many of these students live in the local streets, I don't want this facility to become a hang-out or area for trading drugs, vaping, or other illegal activities. Sometimes items are found in the playground currently to avoid children getting hurt. Teenagers/tweens rove the streets along here on bikes without helmets causing issues and even drunken behaviour is reported regularly to police around this park. I'd be more inclined to support this aspect of the design if it was away from residential housing and in a location where people constantly driving along South Road could monitor it. Further information is needed on this. I HIGHLY SUPPORT the changes to the playground. The current facilities are rusted, dangerous and don't support any young children to play. These facilities are in dire need of an upgrade. They would be used a lot more if they were in better condition. There are always families wandering around the park or taking their dogs to the area to run around. Due to the range of accessibility needs of residents, having accessible features and a nature-based focus on the play space would be highly encouraged. I have no issue with the irrigation (as long as it is recycled water) and grass based running track. Any throwing events, I agree to have headed in the same direction as on the plan (throwing south). I support IN THEORY an athletics group using the space but feel that not enough information has been provided on what the logistics of this are going to look like. How often will it be used? What access will local residents have to the park? Can we continue to use the space as we do? What purposes would they need lights? Athletics is a summer sport when we have daylight savings hours. Soccer and AFL as winter sports occur mostly during the day. There are other facilities in the direct vicinity of this park that would support these other sports at night time and they are already equipped for this. I would not support sports events occurring outside of EPA rubbish collection/street sweeping timeframes for noise provided (9 am and 7 pm on a Sunday or public holiday, or between 7 am and 7 pm on any other day.) I do wonder what suggestions are being made for starting races as pistols or starting guns are likely to stir up local dogs and cause additional anxiety for people. I have anxiety issues around loud noises like bangs from fireworks or backfiring cars. View why Olympics don't use starter pistols https://www.mentalfloss.com/article/31429/why-they-stopped-usingreal-pistols-start-olympic-races The planting of additional trees and shrubs I support IN THEORY, but feel the location needs reviewing or at least negotiation with the local residents along the edge of the



park. I purchased my property due to the view across into the park and then it didn't feel like I was closed into a tight suburban area. If shrubs were planted to stop that view I would be extremely upset. I have had discussions with my real estate agent, this would reduce the value of my property. I STRONGLY oppose any changes that will impact the value of my property and my financial position. I have previously contacted the council about a large amount of loss of tree coverage around this park (which is not indicated on this plan). I support the re-planting of additional tree and shrub coverage along the South Road boundary of the park. Any further changes to planting should be made in consultation with the resident directly opposite that area. The consideration of any footpaths through the treed areas or mulching should only be done if a full independently environmental impact study is completed. While I see the benefits of the path, my suggestion would be to complete the existing footpath (like along the edge of Coorumbena Crescent) along the boundary of the park rather than putting another one through the vegetated sections. Through my university studies last semester, I discovered that the ground below the trees along the boundary of the park and open grassed areas in the park are actually home to ground burrow sweat bees. These bees (Family: Halictidae) are only 2-3mm in size and prefer to burrow into clay-based soils to nest. Given the clay-based nature of the soil in Knox Park and it is a perfect habitat for them. As vital pollinators, they are important to protect. This means considerations on maintenance of the park (no pesticides, herbicides, or chemicals), use of line marking chemicals by any sporting club, and restrictions on construction workers should be of high importance for the environmental future. My suggestion would be the development of a council-wide policy for the management of parks to support pollinators (Pollinator-Friendly Parks Policy). This is part of your DUTY OF CARE to protect the environment from climate change and environmental damage. I don't support any fencing as this may restrict the space being used for other community events, fetes, car club gatherings, etc. I would support investigations into how to stop motorbikes and cars driving directly across the park as they do now. Even the other day there was a van pulled up overnight on the grassed area. I don't feel that any consideration for any grandstands, sportsrooms or clubrooms is required. Toilet facilities will be enough to allow changing if required, bathrooms during events and small storage space for equipment of high jump mats, etc. Little more than this would be required at the current facilities that are hired at a high school. I don't support any venues that may require liquor licensing as there are nearby venues that offer those facilities. I don't support any venues that encourage events to run after 7pm at night. There are children that live around the park that need to get to sleep.




