5. Mayor's communication

5.1 ACTING MAYOR'S REPORT

New CEO - Alastair Dawson

It's my pleasure to announce that Alastair Dawson has been appointed as CEO for the City of Onkaparinga, commencing on 18 July.

Alastair brings with him a wealth of experience as a dynamic and transformative leader in the local government and education sectors.

As CEO of Rockhampton City Council from 2008–2010, he led the organisation's financial and operational turnaround.

He successfully delivered a 10 year financial plan, a 25 year capital plan, an effective regional tourism and business development strategy for Rockhampton, and drove the successful corporatisation of the council's water and wastewater business.

This performance was recognised by the State Government of Queensland and various industry experts as the most successful state-run amalgamation of the time.

Prior to this he was CEO of Beaudesert Shire Council, and has held various executive leadership roles with Brisbane City, Logan City, and Albert Shire councils.

Following his time in local government, Alastair transformed the CQUniversity from an institution in decline, into one of the largest and most successful universities in the country, and oversaw the establishment of an international campus in Jakarta.

Council was impressed with his ability to convert vision and strategy into ambitious but achievable targets while managing genuine organisational change within strong governance frameworks to ensure sustainable performance.

Council also took note of Alastair's preference for a coaching style of leadership, where executives and staff are empowered to deliver and managed on performance, but not micromanaged for service outcomes.

To quote Alastair "too many executives these days forget that they spent considerable time recruiting excellent staff, then forget to let them do their jobs."

Ultimately we selected Alastair because he has the experience and the runs on the board to deliver for us, and build on the great work the entire team has delivered over the last three years.

On behalf of the elected members and all staff, I also want to recognise and thank Julia Grant for stepping up as our acting CEO during the recruitment process.

Julia has been an outstanding leader, employing her considerable political acumen to position us strongly, keep us on track during the Annual Business Plan and Budget process, and support teams across the organisation to continue their great work.

Draft ABP and Budget 22–23

The City of Onkaparinga has proposed a CPI rate increase and we're looking for the community's feedback on our draft Annual Business Plan (ABP) and Budget 2022–23.

We made a commitment to keep rates to CPI and stick to our Long Term Financial Plan principles, which is steering council on a path to financial sustainability and responsibly managing our debt.

That's what's reflected in the 4.7 per cent rate revenue increase applied to our draft 2022-23 operating budget, which is now out for community consultation until Thursday 23 June.

This is a balanced decision—a balance between our commitment to keep rates to CPI and to cover the increase in our costs to meet the needs of our city.

To ensure we keep rates to CPI, this year we're going to absorb the growth cost pressures in our city, which this year represents an additional 0.6 per cent.

If we didn't find a way to absorb this, it would have pushed the rate increase to 5.3 per cent.

Instead, we'll find an additional \$820,000 in savings to ensure we can deliver a rate revenue increase that remains aligned to CPI at 4.7 per cent.

Council's draft ABP outlines how council will spend your rates to deliver essential services and projects across the City of Onkaparinga.

The ABP's actions are aligned with the vision set out in council's Community Plan 2030, backed by a suite of strategic plans and the voices of the community (e.g. residents that took council's Community Survey 2021).

Towards Zero Emissions Roadmap

The City of Onkaparinga has developed a Towards Zero Corporate Emissions Roadmap, which sets a target of 80 per cent reduction in its corporate greenhouse gas emissions by 2030.

The roadmap builds on council's slashing of emissions by almost half over the past decade following a slew of energy-reducing projects.

Its 2030 timeframe has been identified by the Intergovernmental Panel on Climate Change as the most critical to making rapid, deep and sustained greenhouse gas emissions cuts to limit global warming.

The roadmap outlines how council will achieve its target across four key areas:

- buildings continue to install solar and improve energy efficiency in council-managed buildings
- streetlighting to be 100 per cent LED by 2025
- fleet and plant– ensure 80 per cent of council fleet vehicles are electric or hydrogen by 2035
- recycled material buy back 50 per cent of kerbside recycling plastics collected by 2024-25.

I'm proud of council's track record in managing corporate emissions in a financially sustainable manner.

We've been tracking and reporting on our corporate greenhouse gas emissions since 1998, and we've managed a 47 per cent reduction in corporate emissions since 2020-11. Our energy use has also reduced by 33 per cent during the same period.

Our new roadmap builds on this by setting a trajectory toward an ambitious but achievable further reduction in our emissions.

Reductions to date included changing 12,000 streetlights to 14-watt LED technology in 2018, installing 1000 solar panels at council's three highest energy-consuming sites, and circular procurement targets prioritising recycled materials in council projects.

The roadmap's projects are primarily funded through council's Revolving Resources Fund—dedicated to funding energy efficiency, renewable energy and sustainability projects that generate cost savings. These savings are put back into the fund for reinvestment in future energy-reducing projects.

The roadmap projects will not only be good for the planet, they'll continue reducing our operating budget by lowering ongoing costs of fuel and electricity, which is great news for our ratepayers.

Adelaide National Park City Month

A June-long celebration of Adelaide becoming a National Park City is being held across Greater Adelaide, with heaps of events taking place in Onkaparinga.

Adelaide—extending from Salisbury to the north and Aldinga to the south—became Australia's first National Park City and the second globally (after London) in 2021.

The honour begins a journey to improve city life through everyday actions to enjoy connecting with nature and each other.

To celebrate, Green Adelaide has invited partners, including local councils, to contribute events for a June-long celebration and an online calendar has been created.

City of Onkaparinga and other organisations in the south are hosting a range of activities for all ages, with sessions available online and in person across the region, including at our libraries, community centres and national and conservation parks.

You'll find guided walks; workshops on topics such as pruning, wood carving, nature journaling and drawing, kitchen gardening, electric cars and beekeeping; an interactive climate change game; come-and-try kayaking; planting days and much more.

National Park City is a global movement to create cities worldwide where people and nature are better connected.

The movement is managed by the National Park City Foundation, a registered charity established to bring the idea of National Park Cities to life internationally.

Flood protection for Onkaparinga communities

The federal government is investing more than \$9.5 million for a safety upgrade to the Mount Bold Dam, preparing and preventing Onkaparinga communities from future devastating flood events.

The announcement earlier this month followed years of advocacy from the local community and City of Onkaparinga.

We're thrilled with the funding through the National Flood Mitigation Infrastructure Program because the upgrade will help protect the lives and properties of the Old Noarlunga community.

Securing additional flood protection has been a key focus of council since the funding shortfall was identified in 2019, and it has been the number one priority in our Advocacy Plan, so it's fantastic our hard work and funding commitment has come to fruition.

This decision recognises the community needs to be future proofed from the impacts on the increased risk of flooding caused by climate change, minimising the risk of another devastating flood event in Old Noarlunga.

A huge thank you to the federal government and Senator McLachlan, who has been instrumental in achieving this outcome. Thanks also to the state government for joining forces with us in the funding application and co-contribution.

Finally, thank you to the community for making your voices heard, particularly the Old Noarlunga Community Residents Association, which also advocated tirelessly.

The \$325 million Mount Bold Dam Safety Project is part of SA Water's upgrade of the Mount Bold reservoir dam, which was to provide protection for a one-in-18-year Annual Exceedance Probability (AEP) flood event if the reservoir was full.

We agreed to join forces with the state government in its application for federal funding in February, and this included a council and state co-contribution of \$1.5875 million.

The federal funding means a superior flood option can now be built, offering protection for a one-in-100-year AEP flood event if the reservoir is full.

The project will now provide a level of security for Old Noarlunga residents, alleviating social stress and fear of floods, increasing house prices and reducing insurance premiums.

We'll look to spread its financial commitment over several years to minimise the impact on ratepayers, with the payment to be considered as part of its annual budget and Long Term Financial Plan update process.

Detailed design is currently taking place, with construction currently expected to start in 2023, and take approximately three-and-a-half years.

Stay healthy and active this winter

Don't let this recent burst of wild and woolly weather force you into winter hibernation!

There are a range of fun ways to keep active and healthy (and warm) in the City of Onkaparinga right now for all ages, and we recently shared seven great ideas via our news website onkaparinganow.com.

- 1. Visit the Noarlunga Aquatic Centre, which offers a variety of activities such as leisure and lap swimming, and fun swims that include the use of the crazy race inflatable and Tarzan rope. Swimming lessons are offered six days a week for babies to adults of all abilities. There's also a poolside sauna and spa for when you need to unwind and recover. The centre includes a fully equipped gym with qualified instructors to support you through your journey. For those that want variety and support, there is a wide selection of group fitness classes to select from.
- 2. **Head to your local recreation centre.** There's a wealth of options to stay active in winter by visiting one of City of Onkaparinga's <u>recreation centres</u>, which offer a number of activities including team sports, fully equipped gyms and creches.
- 3. **Play a round at Willunga Golf Course**, which is a great way to keep your steps up. The course is set among historic gum trees and a meandering creek with superb views of the vines and hills, and were lucky to have it on our doorstep.
- 4. **Join an outdoor exercise session with Outfit Onkaparinga,** which offers free outdoor group exercise sessions with a personal trainer for adults of all ages. Operating each weekday, current sessions are located at Christie Downs, Moana, Christies Beach, Flagstaff Hill and Maslin Beach and all commence at 9.30am.
- 5. **Beat your PB with a weekly five-kilometre parkrun (or walk).** parkrun is a free timed 5km community group run, jog or walk at Christies Beach, Aldinga Beach, Reynella East, Moana and Shiraz Trail (McLaren Vale) at 8am every Saturday morning. Suitable for all ages.
- 6. **Join your local Heart Foundation Walking group.** Heart Foundation Walking is a free community initiative that uses local volunteer walk organisers to lead small groups of people on walks in the local area. Walks are scheduled on a regular basis and are conducted in a fun, supportive and social atmosphere.
- 7. If you're aged 6-16, you can join Roger Rasheed Sports Foundation's free sport and recreation programs. The Roger Rasheed Sports Foundation is collaborating with council to provide free sport and active recreation programs for the local community. The program's focused at Niipu-niipu Wama/Morton Park in Christie Downs and the current programs open for registrations are free Term 2 sessions on tennis, Muay Thai and skateboarding.

Many of these programs are part of council's Healthy Active Lifestyles Onkaparinga (HALO) program, which is designed to help the community to 'Find your 30' minutes of moderate-to-intense physical activity each day. Head to onkaparinganow.com for the details.

Message from LGA President, Angela Evans: State budget – library and jetty funding

Ahead of the State Budget being handed down 2 June, I have written to the Treasurer to highlight two immediate and practical issues requiring an immediate injection of state government funding: jetties and public libraries. These are issues the LGA has been discussing with the State Government and are actively progressing with relevant departments.

Highlighted in the LGA's Local Voices campaign, the two asks include:

- Funding for public libraries to restore indexation funding, allocate an additional \$1 million each year over four years to continue delivery of digital inclusion programs, and fund a grants program to drive innovation and reform in the library network.
- \$10 million investment for jetty maintenance and to release the SA Jetties Strategic Plan.

We will continue to advocate for these issues alongside the other asks in our advocacy plan.

Message from LGA President, Angela Evans: Council elections preparation

Preparations for the 2022 council elections are well underway, with an advertising campaign in development with ECSA and a range of resources and training opportunities available to help councils through this process.

Post-election support and training will be available, and we are working closely with our partners Norman Waterhouse Lawyers and LG Professionals SA to finalise a range of options for new council members.

Separately, pre-election support for candidates will include an information booklet, a candidate information session at LG House and via online seminar on Saturday 23 July 2022, and a presenter's guide and presentation that can help councils hold their own

candidate sessions. The LGA is also able to support local or regional candidate information sessions if required. If you are interested in this, please contact <u>LGA Training</u>.

We are also offering pre-election training for council staff covering topics such as council transition planning, understanding the caretaker model policy and the council induction program.

Ongoing updates will be provided to council's nominated election representatives.

Message from LGA President, Angela Evans: LG Reconciliation Industry Network Group

Last Monday, the LGA with Reconciliation SA hosted over 30 mayors and CEOs from across SA at a meeting of the Local Government Reconciliation Industry Network Group, LG RING. The discussion gave an opportunity to highlight and share stories of SA Reconciliation Action Plan initiatives. Councils were also encouraged to talk about being a councillor with First Nations peoples who may be interested in local government and how to support them in nominating.

We also welcomed Keith Thomas, CEO of South Australian Native Title Services, who spoke on the importance of native title, reconciliation, and connecting with community. The discussion centred on the importance of building relationships between First Nations people and the wider Australian community as part of our reconciliation journey.
